**(LIQUIDATOR'S APPLICATION TO
PAY INTERIM DISTRIBUTION)**

Bruce R. Ramage, Liquidator (the "Liquidator") of Amwest Surety Insurance Company ("Amwest"), applies to the Court for an Order authorizing the Liquidator to pay an interim distribution to certain claimants.

1. The Liquidator makes this application pursuant to NEB. REV. STAT. §44-4844, which allows the Liquidator to pay distributions under the direction of the Court in a manner that will assure the proper recognition of priorities and a reasonable balance between the expeditious completion of the liquidation and the protection of unliquidated and undetermined claims.

2. The Liquidator seeks Court approval to pay from its general assets an interim distribution to Class 3 Policyholder Claimants, as defined in NEB. REV. STAT. §44-4842(3) in effect on June 7, 2001, the date of the Order of Liquidation, Declaration of Insolvency, and Injunction herein.

3. The Liquidator seeks to pay an interim distribution equal to ten percent (10%) of the net approved claim amounts of Class 3 Policyholder claims. The total dollar amount of the interim distribution for which approval is sought is \$4,759,712.77. Together with the prior twenty-five percent (25%) and fifteen percent (15%) interim distributions, this distribution will result in aggregate distributions of fifty percent (50%) of the net approved claim amounts of Class 3 Policyholder claims. Including distributions for which approval is sought in this application, the total general asset distributions in respect of Class 3 Policyholder claims are \$23,757,003.87.

4. Every claim in every class having priority over Class 3 Policyholder claims has been paid in full or adequate funds have been retained for such payment. Adequate funds have also been retained to assure appropriate treatment of all Class 3 Policyholder claims which are unliquidated and undetermined on the date of this Application. The Liquidator intends to pay one or more additional distributions to Class 3 Policyholder claimants subject to the completion of the claim adjudication process and the collection of remaining assets.

5. Attached hereto as Schedule 1 and incorporated herein by reference is a true and correct listing of the names and addresses of each nonbail surety Class 3 Policyholder claimant to whom the Liquidator seeks to make a distribution and the dollar amount of such distribution. Attached hereto as Schedule 2 and incorporated herein by reference is a true and correct listing of the names and addresses of each bail surety Class 3 Policyholder claimant to whom the Liquidator seeks to make a distribution and the dollar amount of such distribution.

6. To the best of the Liquidator's knowledge and belief, the claims covered by this application are not subject to modification by the factors specified in Application No. 62 (For Order Modifying Approval of Liquidator's First Claims Report), or those factors have already been

accounted for, as reflected on the attached schedules. If any additional factors addressed in Application No. 62 hereafter come to the Liquidator's attention, such as third party payments or releases of any such claims, or the existence of specific assets (assets held for the benefit of some but not all claimants) securing any such claims, the Liquidator will promptly bring those matters to the Court's attention in a supplemental report or an application to modify such claims as the case requires.

7. The Liquidator further applies to the Court for authority to make distribution payments to all similarly situated Class 3 claims which have received Court approval and which either have been confirmed by the claimant or are exempt from the Liquidator's confirmation process, subject to reporting to the Court from time to time. The aggregate amount of such distributions shall be fifty percent (50%), consisting of the twenty-five percent (25%) interim distribution initially approved on October 20, 2008, the fifteen percent (15%) interim distribution initially approved on June 25, 2009, and the ten percent (10%) interim distribution which is the subject of this application.



Michael J. FitzGibbons, being first duly sworn, deposes and says as follows:

1. I am the Special Deputy Liquidator of Amwest Surety Insurance Company ("Amwest"). I was appointed to my position by L. Tim Wagner, the late Liquidator of Amwest, I served at the request of Ann M. Frohman, the immediate past Liquidator, and continue to serve in my position at the request of Bruce R. Range, the current Liquidator. In my position, I am personally involved in the liquidation of Amwest, including the matters addressed in this Affidavit and I have personal knowledge of the matters addressed in this Affidavit.

2. I am submitting this Affidavit in support of Application No. 109, containing the Liquidator's application pursuant to NEB. REV. STAT. §44-4844 to approve an interim distribution of Amwest's general assets to approved Class 3 policyholder claims made under NEB. REV. STAT. §44-4842(3). Application No. 109 requests the Court's approval to pay an additional ten percent (10%) general asset distribution to approved Class 3 policyholder claims over and above the twenty-five percent (25%) and fifteen percent (15%) general asset distributions previously approved by the Court, which if approved will result in aggregate general asset distributions of fifty percent (50%) to approved Class 3 policyholder claims.

3. My responsibilities in the liquidation of Amwest include oversight of and active involvement in the liquidation process. I have been actively involved in the liquidation at all times since Amwest was placed into liquidation. I am familiar with Amwest's claims process and with the claims that have been filed.

4. Every claim in every class having priority over Class 3 Policyholder claims has been paid in full or adequate funds have been retained for such payment. Adequate funds have

also been retained to assure appropriate treatment of all Class 3 Policyholder claims which are unliquidated and undetermined on the date of this Application.

5. Attached to Application No. 109 as Schedules 1 and 2 are true and correct listings of the names and addresses of each Class 3 Policyholder claimant to whom the Liquidator seeks to make a distribution and the dollar amount of such distribution.


6. To the best of the Liquidator's knowledge and belief, the claims covered by this application are not subject to modification by the factors specified in Application No. 62 (For Order Modifying Approval of Liquidator's First Claims Report), or those factors have already been accounted for, as reflected on the attached schedules. If any additional factors addressed in Application No. 62 hereafter come to the Liquidator's attention, such as third party payments or releases of any such claims, or the existence of specific assets (assets held for the benefit of some but not all claimants) securing any such claims, the Liquidator will promptly bring those matters to the Court's attention in a supplemental report or an application to modify such claims as the case requires.

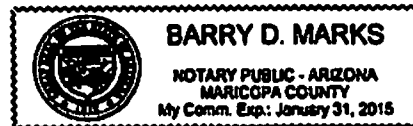

This matter came on for consideration on Application No. 109 of the Director of Insurance for the State of Nebraska, Bruce R. Ramage, acting as Liquidator of Amwest Surety Insurance Company pursuant to the Insurers Supervision, Rehabilitation and Liquidation Act ("Act"), NEB. REV. STAT. § 44-4801 *et seq.*, particularly NEB. REV. STAT. §44-4844, for an Order approving an interim distribution to Class 3 Claimants.

The Court finds that the claimants covered in the Liquidator's Application No. 109 are Class 3 Policyholder claimants under NEB. REV. STAT. §44-4842(3), as it existed on June 7, 2001, the date of Amwest's Order of Liquidation, Declaration of Insolvency, and Injunction herein. The Court further finds that priority classification is appropriate for distributions in this liquidation by reason of NEB. REV. STAT. §44-4818(2), whereby the rights and liabilities of the insurer, its creditors and

others are fixed as of the date of the Order of Liquidation herein. The Court further finds that the Liquidator's Application No. 109 seeks approval to make a ten percent (10%) general asset distribution to approved Class 3 policyholder claimants, which together with the twenty-five percent (25%) and fifteen percent (15%) general asset distributions previously approved by the Court, will result in the Court's approval of aggregate fifty percent (50%) general asset distributions to approved Class 3 policyholder claimants.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED:

1. Pursuant to NEB. REV. STAT. §44-4844, the Liquidator is **AUTHORIZED AND ORDERED** to pay distributions to the claimants as listed on Schedules 1 and 2 attached to Application No. 109.

2. The Liquidator is further **AUTHORIZED AND ORDERED** to pay claim distributions on any similarly situated Class 3 claims which have been approved by the Court and which have either confirmed the claim or are exempt from the Liquidator's confirmation process, and the Liquidator shall report to the Court on the payment of such claim distributions not less often than quarterly.

3. As a condition to making any distribution to any claimant hereunder, the Liquidator is authorized to require the affected claimant to represent in writing to the Liquidator, by endorsement of the claims distribution check or otherwise, under penalties of perjury, that (a) the claimant is the holder of the claim free and clear of any rights or claims of third parties created by the claimant, (b) the claimant has not made any transfer, release, assignment or pledge of such claim, and (c) the claimant has not received any payment on such claim from any other source. The

Liquidator may reduce or withhold payment to any claimant as appropriate to the extent such claimant no longer holds such claim, or has transferred, released, assigned or pledged such claim, or has received payment on such claim from any other source, and if any such situations exist, the Liquidator shall make a supplemental report to the Court, and, as necessary, an application to modify or disallow the affected claims.
